
N ½ STN GRDS WHITEMOUTH

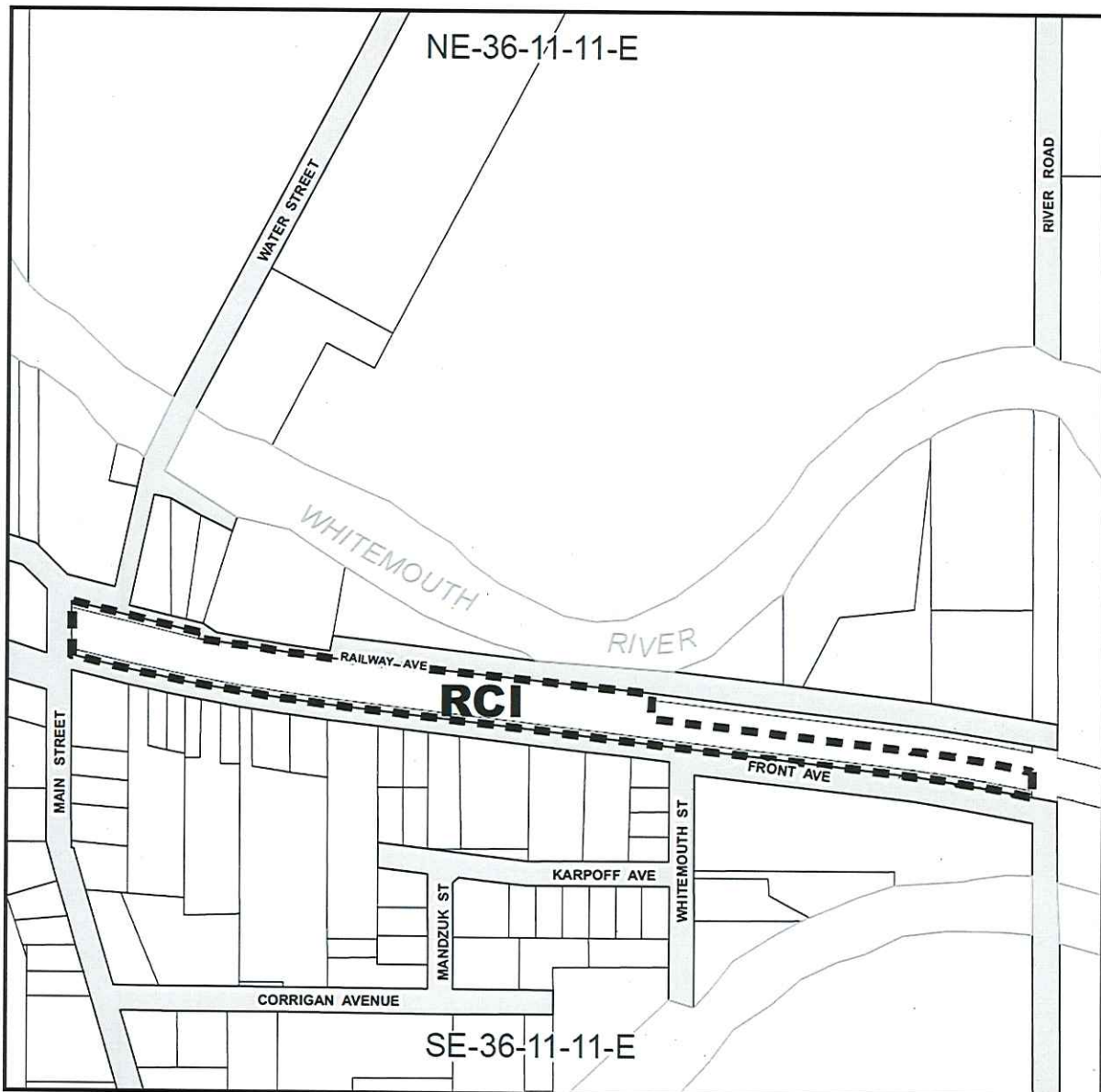
